Notice of Solicitation

Notice is hereby given that pursuant to the provisions of N.J.S.A. 40A:11-5(1)(a)(ii) and N.J.A.C. 5:34-2.3(b) the Knowlton Township Board of Education, located at 80 Route 46, Delaware, New Jersey 07833, is seeking responses to this Request for Proposal (RFP) for the following professional services to be provided to the Board of Education as listed below for the period January 1, 2020, to December 31, 2020.

Contract Term

As per N.J.S.A. 40A:11-15(6), the Knowlton Township Board of Education shall award a one (1) year contract term from January 1, 2020 to December 31, 2020, with the option of two (2) one (1) year extensions, not to exceed three (3) years.

All statements of proposals for professional service contracts shall include at a minimum the following information:

- 1. Names of individuals who will perform required tasks as well as the listing of their licenses.
- 2. Identify the person who will be primarily responsible for the services required by the Board of Education and provide a description of the experience of the primary person with projects and issues similar to those more specifically set forth in this proposal and on behalf of the Knowlton Township Board of Education.
- 3. Identify persons who will serve as back up to the primary person including resumes of all parties.
- 4. Describe ability to provide services in a timely fashion including a description of your staffing.
- 5. Provide information related to any applicable fees for your services.
- 6. Provide copy of Applicant's Certificate of Employee Information Report and/or copy of Applicant's New Jersey Business Registration Certificate if applicable.

Submission

Proposing firms shall provide evidence that the minimum proposals are met. Proposal should also include cost details including hourly rates of the individuals who perform services and a list delineating the numbers and types of public clients represented by the individual broker and firm.

Evaluation of Proposals

The School District intends to award a extraordinary unspecifiable service contract for the defined scope of work in accordance with N.J.S.A. 40A:11-5(1)(a)(ii) and N.J.A.C. 5:34-2.3(b).

The proposals will be evaluated by a committee of staff and Board Members of the School District based upon information supplied by each Proposer in response to this RFP and the following criteria:

- Ability to meet all minimum proposals.
- Overall knowledge and familiarity with the operations of the School District.
- Experience of the firm in providing similar services to other public bodies with special emphasis on experience in New Jersey.
- Proposals and experience of the professional.
- Proposals and experience of the other members of the professional's firm.
- The hourly rates proposed. The proposal shall identify whether clerical and other overhead costs will be billed separately or included in the hourly labor rate for the broker.

Professional Experience

- 1. Names of the two (2) primary individuals who will perform required tasks for the Board of Education as well as copies of their entity and individual New Jersey Insurance Producer Licenses.
- 2. A minimum of ten (10) years experience handling insurance coverage for Boards of Education in New Jersey.
- 3. A minimum of five (5) years experience representing clients with coverage through the New Jersey School Insurance Group (NJSIG).
- 4. Applicant must be an approved Broker of the NJSIG and deal directly with NJSIG without the need for a fronting Broker.
- 5. Experience handling Board of Education Builder's Risk Insurance Coverage in connection with school construction projects as well as standard lines of coverage.
- 6. Provide a list of five (5) New Jersey Boards of Education represented by the Applicant with coverage through NJSIG.
- 7. A statement that the Applicant has not had any claims of malpractice made against Applicant during the last five (5) years in connection with Applicant's representation of a New Jersey Board of Education.
- 8. Applicant must maintain its principal office within the State of New Jersey.

Scope of Services

The Board of Education desires to appoint an Insurance Broker, who is familiar with the current primary New Jersey School Insurance Group coverages. Additional considerations are that the Insurance Broker has a good working relationship with NJSIG and has knowledge and familiarity with other available New Jersey school board insurance programs
